Investment Objective

To earn a competitive rate of return while preserving capital to the extent possible by investing in liquid assets.

Fund Manager Commentary

The Fund posted an annualized return of 10.8% during September 2014 versus the Benchmark return of 10.2%. The annualized return in the FYTD is 10.7% against the Benchmark return of 10.2%, hence an outperformance of 0.5% p.a. This outperformance is net of management fee and all other expenses.

As the allocation of the Fund shows, exposure in TFCs and Sukuks stands at 41.9%. All TFCs in the Fund are floating rate instruments linked to KIBOR.

The weighted average Yield-to-Maturity of the Fund is around 11.5% p.a. while its weighted average time to maturity is 1.5 years. This yield does not include potential recovery in fully provided TFCs (Face Value of Rs. 312 million), which is potential upside for the Fund. Thus, the Fund is expected to perform well over the medium to long term horizon. However, since TFCs prices may go up or down only investors with medium term investment horizon are advised to invest in this Fund.
