G. K. The Management Company and the Trustee amended certain provisions of the Amended and Re-Stated Trust Deed by virtue of the powers continue of inclusive 20 of the Initial Trust Deed; mainly for the purpose of recording the change of name of Fund from "NAFA Islamic Asset Allocation Fund" to "NBP Islamic Sarmaya Izafa Fund", amendments in Clause 2 relating to Benchmark and Clause 15.1 relating to Determination of Distributable Profits.

- L. The SECP approved the amendments to the Amended and Re-Stated Trust Deed vide its letter No.SCD/AMCW/NAFA/294/2019 dated February 12, 2019, attached herewith as Annexure "F".
- M. The Management Company and the Trustee executed the First Supplemental Trust Deed dated February 19, 2019, which was registered with Sub-Registrar-I, Jamshed Town, Karachi under Registered No.129, Book No.IV dated 27-02-2019, DSU, KHI, BoR, Sindh, RD:129/SRO:17/DocType:34 dated 19-03-2019.
- N. Due to the enactment of the Sindh Trusts Act, 2020, as amended vide Sindh Trusts (Amendment) Act, 2021, the Trust, being a Specialized Trust is required to be got registered with the Assistant Director of Industries and Commerce, Government of Sindh under Section 12A of the Sindh Trusts Act, 2020. For this purpose, this Re-Stated Trust Deed is being executed between the Management Company and the Trustee, while maintaining the continuity of the Trust and without affecting actions taken, transactions effectuated, documents executed by the Unit Holders, Units issued to the Unit Holders and all other acts, things and deeds done by the Management Company and the Trustee, which shall be deemed to have been validly effectuated done and are saved.

c) The Management Company shall establish, manage, operate and administer the Fund in accordance with the Rules Regulations, any directive or circular on the matter this Substituted Trust Deed and the Offering Document as amended from time to time.

6. Effect of this Substituted Trust Deed and Status of Unit Holder(s)

6.1 Deed Binding on Each Unit Holder

The terms and conditions of this Substituted Trust Deed as amended, as per the term of Clause 20 of this Substituted Trust Deed, from time to time shall be binding on each Unit Holder as if the Unit Holder had been party to it and shall be bound by its provisions and shall be deemed to have authorized and required the Trustee and the Management Company to do as required of them by the terms of this Substituted Trust Deed and the Regulations.

- 7.6 The Management Company shall not be under any liability except such liability as may be expressly assumed by it under the Rules, Regulations, this Substituted Trust Deed and the Offering Documents, nor shall the Management Company (save as herein otherwise provided) be liable for any act or omission of the Trustee nor for anything except for its own gross negligence or willful breach of duty and the acts and omissions of all persons to whom it may delegate any of its functions as manager as if they were its own acts and omissions. If for any reason it becomes impossible or impracticable to carry out the provisions of this Substituted Trust Deed and the Offering Document, the Management Company shall not be under any liability thereof or thereby and it shall not incur any liability by reason of any error of law or any matter or thing done or suffered or omitted to be done in good faith hereunder.
- 7.7 The Management Company shall nominate and notify to the Trustee one or more of its officer(s) to act as authorized persons for interacting with and giving instructions to the Trustee.  - a) a document signed or purporting to be signed on behalf of the Management Company by any authorized representative(s) whose signature the Trustee is for the time being authorized in writing by the Management Committee to accept; and
 - b) any Instructions received online through the software solution adopted by the Management Company/Trustee in consultation with each other shall be deemed to be instructions from the authorized representative(s).

8.6 The Trustee shall not be liable for any loss caused to the Fund or to the value of the Trust Property due to any elements or circumstances of Force Majeure

9. Trust Property

9.1 The aggregate proceeds of all Units issued from time to time after deducting Duties and Charges, Transactions Costs and any applicable Sales Load, shall constitute part of the Trust Property and includes the Investment and all income, profit and other benefits arising there from and all cash, bank balances and other assets and property of every description for the time being held or deemed to be held upon trust by the Trustee for the benefit of the Unit Holder(s) pursuant to this Substituted Trust Deed but does not include any amount payable to the Unit Holders as distribution. However any profit earned on the amount payable to the Unit Holders as distribution shall become part of the Trust Property.

9.4 Except as specifically provided in this Substituted Trust Deed, the Trust Property shall always be kept as separate property free from any mortgages, charges, liens or any other encumbrances whatsoever and the Trustee or the Custodian shall not, except for the purpose of the Scheme as directed by the Management Company, create or purport to treate any mortgages, charges, liens or any other encumbrance whatsoever to secure any loan, Eguarantee or any other obligation actual or contingent incurred assumed or undertaken by the Trustee or the Custodian or any other person.

9. Voting Rights on Trust Property

All rights of voting attached to any Trust Property shall be exercisable by the Management Company on behalf of the Trustee and it shall be entitled to exercise the said rights in what it may consider to be in the best interest of the Unit Holders and may refrain at its own discretion from the exercise of any voting rights and the Trustee or the Unit Holders shall not have any right to interfere or complain.

The Trustee shall upon written request by the Management Company and on account of the Trust Property, from time to time execute and deliver or cause to be executed or delivered to the Management Company or their nominees powers of attorneys or proxies authorizing such attorneys and proxies to vote, consent or otherwise act in respect of any investment in such form and in favor of such persons as the Management Company may require in writing.




