**Investment Objective**  
The objective of the Fund is to provide investors with long term capital growth from an actively managed portfolio of Shariah Compliant listed equities.

**Fund Manager Commentary**  
During the month under review, NBP Islamic Stock Fund's (NISF) unit price (NAV) decreased by 0.6%, whereas the Benchmark increased by 1.1%, thus an underperformance of 1.7% was recorded. Since inception on January 9, 2015 your Fund NAV has increased by 6.1% p.a versus 4.7% p.a by the Benchmark. Thus, to-date the outperformance of your Fund stands at 1.4% p.a. This outperformance is net of management fee and all other expenses.

NISF started off the month with an allocation of around 91% in equities which was increased to around 96% towards the end of the month. NISF underperformed the Benchmark in March as the Fund was overweight in select Textile Composite, Cement, Transport and Engineering sectors stocks which underperformed the market and underweight in select Fertilizer, Technology & Communication and Automobile Assembler sectors stocks which outperformed the market. During the month, the allocation was primarily increased in Technology & Communication, Pharmaceuticals, Fertilizer, Cement, Engineering sectors, whereas it was reduced primarily in Oil & Gas Marketing Companies, Cable & Electrical Goods, Oil & Gas Exploration Companies and Commercial Banks sectors.

**Sindh Workers' Welfare Fund (SWWF)**  
During the month of August 2021, provisioning against Sindh Workers' Welfare Fund by NBP ISLAMIC STOCK FUND amounting to Rs. 83.10 million has been reversed on the clarification received by Sindh Revenue Board vide letter No. SRB/TP/70/2013/8772 dated August 12, 2021 addressed to Mutual Funds Association of Pakistan. This reversal of provision has contributed towards an unusual increase in NAV of the NBP ISLAMIC STOCK FUND by 1.06% on August 13, 2021. This is one-off event and is not likely to be repeated in the future.
